# Modi, Trump speak; U.S., India call accounts differ

Leaders extend Deepavali greetings over phone; while U.S. President says Modi conveyed decision to stop buying Russian oil and discussed India-Pak. peace, India denies Pakistan was discussed

ays ahead of a possible meeting in Kuala Lumpur, and amidst intense ongoing trade negotiations, U.S. President Donald Trump called Prime Minister Narendra Modi on Tuesday to extend Deepavali greetings, the leaders said. However, the two sides differed vastly in their comments following the call.

Mr. Modi referred to a united stance on terrorism, while Mr. Trump said the conversation focused on the trade deal. Russian oil, and ensuring "no war with Pakistan". However, government sources insisted that Pakistan was not discussed during the call.

"I just spoke to your Prime Minister today," Mr.

Trump said on Tuesday, addressing the "people of India" directly in comments at the White House where he held a special Deepavali celebration for prominent Indian-Americans and Indian Embassy officials. "We had a great conversation. We talked about trade. We talked about a lot of things, but

mostly the world of trade. We had a great He's very interested in conversation. that," he added.

A few hours later, the Prime Minister thanked the U.S. President for his phone call and "warm Diwali greetings". "On this festival of lights, may our two great democracies continue to illuminate the world with hope and stand united against terrorism in all its forms," Mr. Modi said, without offering any further details.

The Ministry of External Affairs did not comment on the discussion between the two leaders, who are both due to travel to Malaysia this weekend to attend ASEAN-related summits, including the East Asia Summit together.

A month after four persons, including a Kargil war veteran, were killed in police action against protesters seeking Ladakhi Statehood, civil society groups resumed talks on the region's status with Ministry of Home Affairs officials (MHA) Wednesday.

# Come November 1, Kerala will officially be first State 'free of extreme poverty'

Kerala Chief Minister Pinarayi Vijayan will officially declare the State free from extreme poverty at a function to be held at Central Stadium in the capital on November 1.

Actors Mohanlal, Mammootty and Kamal Haasan will be special guests at the event to which all State Ministers as well as Leader of the Opposition V.D. Satheesan will be invited, Minister for Local Self-Governments M.B. Rajesh said at a press conference in Thiruvananthapuram on Wednesday.

Mr. Rajesh said the extreme poverty eradication programme began in 2021 as one of the first Cabinet

"According to the NITI Aayog's study in 2021, Kerala is the State with the lowest poverty rate in the country with a poverty rate of 0.7% of the total population. The government took

the lead in reaching out to this small population and meeting their needs. Kerala will become the first State in the country to achieve this landmark," the Minister said.

After ground-level surveys, 64,006 families were

identified as extremely poor, based on factors such as food, health, livelihood, and shelter.

Many marginalised people, whose names were not even on the voters' list and who did not even have a ration card or Aadhaar, were on this list. Micro-plans on the immediate and long-term needs were prepared for each of the families. Essential documents were given to 21,263 individuals lacking these.

He added that 3,913 families were provided houses and 1,338 families land, while 5,651 families received up to ₹2 lakh for renovating their houses.

  - Tendulkar line (2009):

# Govt. proposes mandatory labelling of AI-generated content on social media

The Electronics and Information Technology Ministry on Wednesday proposed mandatory disclosure and labelling of artificial intelligence (AI)-generated "synthetic" content on social media platforms.

The Ministry released a draft amendment to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, that requires social media companies to allow users to self-declare if the content they upload is AI-generated. In cases where users fail to make such declarations, platforms must proactively de-

#### Disclosure mandate

The draft amendment to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, outlines the Ministry's proposed approach to regulating synthetic content

- All synthetic content whether video, photo, audio, or text must carry a disclosure
- The disclosure should cover at least 10% of the surface area in all Al-generated audiovisual posts

tect and label AI-generated content.

The declaration must cover 10% of the content's area, and applies to all types of synthetic content, including text, video, and audio, and is not limited to photorealistic content, according to officials and the draft text.

"In Parliament as well as many other fora, people have demanded that something should be done about the deepfakes which are harming society," IT Minister Ashwini Vaishnaw

"People are using some prominent persons' image and creating deepfakes, which are then affecting their personal lives, privacy as well as [creating] various misconceptions in society. So the step we have taken is making sure that users get to know whether something is synthetic or real. Once users know, they can take a call. But it's important that users know what is real. That distinction will be led through mandatory data labelling."

# Officers issuing content notice to be made more 'accountable'

he Union Ministry of Electronics and Information Technology (MeitY) will amend social media takedown rules to make officers sending notices to social media their platforms more "accountable", officials said on Wednesday. The new duced by way of an amendment to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 within this week itself, senior officials briefing the press said.

"The accountability of the government increases with this change," IT Minister Ashwini Vaishnaw told presspersons.

As a part of these new rules, the government "will be giving a reasoned intimation whenever any such order is passed, and orders will be passed at a fairly senior level, Joint Secretary and above for the Central government, and Deputy Inspector-General at the State level", the Minister said.

#### Boosting transparency

The amended rules on social media takedown notices seek to build clarity in government communication and reduce arbitrary or unclear takedown action. The amendment will be notified within a week and is expected to take effect from November 15

#### What is Rule 3(1) (d) of the Information Technology Rules, 2021?

This rule allows government officials to flag online content that may violate Indian laws or pose risks. When flagged under Rule 3(1)(d), social media companies lose 'safe harbour' protection, meaning they can be held legally responsible for the content — like publishers, not just intermediaries

Such notices will force social media firms to defend content as though they were publishers, and not just an intermediary for such content. The amendment has not yet been not-

The safeguards specifially pertain to Rule 3(1)(d) if the IT Rules, under thich government officials re empowered to flag conified in the Gazette, but officials said it would be done within the week, and would go into effect on November 15.

The social media platform X had challenged the
use of Rule 3(1)(d) as an unconstitutional and arbitrary way for police officers to issue "censorship"
orders from around the
country. A single judge
Bench of the Karnataka
High Court upheld the government's right to empower officials to issue

such notices. Officials briefing the media denied there was any connection between this court case and these safeguards.

#### Why in News:

The IT Ministry will amend the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 to make officers issuing content notices more transparent, accountable, and senior-level authorized. The step follows misuse of notice powers under Rule 3(1)(d) and a Karnataka High Court directive for stronger safeguards.

What is "Safe Harbour" under Rule 3(1)(d)

"Safe Harbour" gives legal immunity to social media intermediaries (like X, YouTube, Meta) from user-posted content – meaning they are not liable for what users upload, as long as they follow due diligence under the IT Rules.

However, under Rule 3(1)(d), if the government flags content as illegal and the platform fails to act, the platform loses this protection, and can be legally prosecuted as if it published the content itself.

Earlier: Under Rule 3(1)(d), even junior officers could issue content notices without explanation. Such notices were treated as takedown orders, not warnings. Platforms automatically lost Safe Harbour, even if the notice lacked justification. There was no rule for written reasoning or officer accountability. This led to arbitrary and opaque enforcement.

Now (Post Amendment): Only Joint Secretary (Centre) or DIG (State) and above can issue notices. Each notice must clearly say it's a "warning," not an order. Officers must give a written, reasoned justification explaining why Safe Harbour doesn't apply. A "reasoned intimation" must accompany every notice for transparency. Officials will be personally accountable for all actions. Effective from November 15, 2025.



# OpenAI unveils AI powered search browser 'Atlas' in a challenge to Google

ChatGPT-maker OpenAIannounced an "Atlas" search browser, leveraging its artificial intelligence prowess in a direct challenge to Google Chrome.

"This is an AI-powered web browser built around ChatGPT," OpenAI chief Sam Altman said in a streamed presentation.

OpenAI has ramped up its challenge to Google, which has responded by rapidly building more AI capabilities into search and across its platform.

Mr. Altman and a team of executives demonstrat-

ed an "agent" mode that has a chatbot to conduct searches on a user's behalf.

Mr. Altman said that in agent mode, ChatGPT uses the web browser indepen-

dently, returning with what it finds. "It's got all your stuff and is clicking around," Mr. Altman said.

"You can watch it or not, you don't have to, but it's using the Internet for you." Atlas will go live on computers powered by Apple's operating system free of charge, but agent mode will only be available to users of paid Plus or Pro versions of ChatGPT, according to Mr. Altman.

"We want to bring this to Windows and to mobile devices as quickly as we can," Mr. Altman said, without providing a timeline. "This is still early days for this project."

Two years after scientists from the National Bureau of Agricultural Insect Resources (NBAIR), under the Indian Council of Agricultural Research (ICAR), released a tiny parasitic wasp lds, the crop that onc from an invasive pest is now thriving again. Farmers in Tamil Nadu, Kerala, and Puducherry report that their tapioca harvests have returned to pre-out break levels. This marks a are success in controlling major agricultural pest

Cassava, better known as tapioca, is grown on about 1.73 lakh hectares in Kerala together contributing more than 90% of total production. Before the outbreak, yields averaged 35 tonnes per hectare, far above the global average of 10.76 tonnes, and India exported value-added tapioca products worth nearly ₹200 million annually, according to NBAIR officials. However, the mealy-

bug's arrival in Thrissur, Kerala, in April 2020 changed this landscape. By 2021, nearly 1.43 lakh hectares were infested, and some areas of Tamil Nadu saw yields collapse to 5-12 tonnes per hectare. The pest fed on the plant sap, causing leaf curling, stunted growth, and poor tuber awareness programmes formation. With no effective local predators, the infestation escalated quickly and posed a serious economic threat to farmers,

Chemical sprays were considered, but repeated



brought the pest under control. eliminating the need for chemical spray, SPECIAL

harmful to the environment, and unsustainable for small farmers. ICAR-NBAIR scientists instead turned to classical biological control, a strategy that fied a tiny parasitic wasp ifically targets the cassava mealybug. The wasp lays its eggs inside the pest, and the developing larvae consumes it from within, naturally reducing mealybug numbers without harming other crops," S.N. Sushil, Director, ICAR-NBAIR said.

The institute imported a shipment from the International Institute of Tropical Agriculture, West Africa.

ICAR-NBAIR set up three satellite mass-production centres, distributed over 2,00,000 parasitoids, and conducted 25 and multiple training sessions. By 2023-24, they had achieved remarkable results. Across the previously infested 1.43 lakh hectares, the mealybug is now under natural control and has eliminated the need for chemical sprays.

- Focus Sectors: Clean energy, green tech, fisheries, medical equipment, and efficiency-based industries.
- Mechanism: Establishes an EFTA Desk in India to coordinate investment, resolve trade issues, and deepen ties.
